- An exposure to the growing sector of Decentralized Finance thanks to self-balancing weighted portfolio of top Defi Tokens.
- Be a liquidity provider & collect fees from traders who rebalance your portfolio by following arbitrage opportunities.
- 100% of the assets are in Cryptos and you gain additional units on a daily basis by functioning effectively as a Crypto Liquidity Provider.

Investment strategy

We focus on Crypto Currency pairs and aim to increase the balance of crypto assets by profiting from relative volatility. A strong focus on the secure storage of the underlying cryptos ensures long term profitability, and is the guiding principal.

This is a Crypto Fund; as such, the contribution to the fund itself is made exclusively in Crypto Currencies.

A fiat bank transfer is facilitated through a Swiss regulated broker. This fiat transfer incurs additional fees of 2% (minimum 300 Euros) that is separate from the fund
